

Vehicle Purchase & Import Agreement

Between

Floyd Kissoon for Lot 18 Kissoon Scheme Good Hope, East Coast Demerara, Guyana
and

Renegade Service Center and Auto Spare (Eddie Singh) of Lot 1370138 Herstelling,
East Bank Demerara, Guyana.

This Vehicle Purchase & Import Agreement (“Agreement”) is made on this ____ day of _____, 2025, between:

1. Buyer:

Floyd Kissoon, residing in Guyana (hereafter referred to as “the Buyer”).

2. Importer:

Renegade Service Center and Auto Spare, located in Guyana (hereafter referred to as “the Importer”).

1. Vehicle Details

The Importer agrees to source, purchase, and import on behalf of the Buyer the following vehicle:

- Make & Model: Toyota Tacoma
- Year: 2015
- Drive Type: 4WD
- Color: White
- Source: Miami, USA
- Chassis Number:

2. Purchase Price & Payment Terms

The total agreed price for the vehicle is GYD \$4,300,000. This amount covers the cost for the vehicle, shipping and the Importer Fee.

The Buyer agrees to pay the Importer as follows:

1. GYD \$4,000,000 – payable by cheque upon signing this Agreement.
2. GYD \$300,000 – payable when the vehicle arrives (lands) in Guyana.

All payments shall be made directly to the Importer.

3. Importer Responsibilities

The Importer agrees to:

1. Import the vehicle from Miami to Guyana on behalf of the Buyer.
2. Provide the Buyer with a three-month warranty covering mechanical and electrical issues not caused by misuse, accidents, or negligence.
3. Scan and full comprehensive service of the vehicle upon arrival in Guyana.
4. Ensure the vehicle has no major issues upon delivery to the Buyer (No Engine related issues, Transmission & Drivetrain issues, Electrical System Issues, Suspension & Steering Issues, Brake System Issues, Cooling System Issues, Structural & Safety Issues, Exhaust System Issues, Dashboard Warning Lights That Cannot Be Cleared) .
5. Notify the Buyer immediately when the vehicle arrives in Guyana.

4. Buyer Responsibilities

The Buyer agrees to:

1. Pay all duties and local taxes associated with importing the vehicle.
2. Pay all brokerage fees required to clear the vehicle.
3. Handle the local registration of the vehicle in Guyana after clearance.
4. Pay the remaining GYD \$300,000 immediately upon the vehicle's arrival.

5. Delivery Terms

- The vehicle shall be delivered to the Buyer after arrival, scanning, servicing, and inspection by the Importer.
- The Importer warrants that the vehicle shall be delivered in good working condition, free from major mechanical faults.

6. Warranty Terms

The Importer provides a three-month warranty from the date the Buyer receives the vehicle.

The warranty covers:

- Engine
- Transmission
- Drivetrain
- Major mechanical systems
- Electrical systems

The warranty does not cover:

- Wear-and-tear items (brakes, tires, shock absorbers, etc.)

- Damage caused by the Buyer
- Accidents, negligence, or modifications after purchase
- The buyer shall not use the vehicle for 'bush' run while the vehicle is covered under warranty.

7. General Provisions

- Both parties agree that this document represents the full and final agreement.
- Any amendments must be made in writing and signed by both parties.
- Both parties confirm that the information provided is true and correct.
- This Agreement shall be governed by the laws of Guyana.
